  the college and forwarded its recommendations and report to the Ministry. A copy of assessment

- 3. The recommendations and visitation report of the CCIM have been carefully examined in terms of the "Indian Medicine Central Council (Requirements of Minimum Standard for undergraduate Ayurveda Colleges and attached Hospitals) Regulations, 2016, provisions under the IMCC Act, 1970, relevant regulations made thereunder and as per approval of the Hon'ble MoS (IC), Ministry of AYUSH for the UG/PG course(s) for grant of conditional permission for the academic session 2017-18 vide Ministry's letter No.R.11011/03/2017-EP (IM-1) dated 12.06.2017 and it is found that the College fulfills the notified and approved criteria.
- 4. It has, therefore, been decided by the Central Government to grant conditional permission to the R.B. Ayurvedic Medical College & Hospital, Jalesar Road, Agra 283126, Uttar Pradesh with 100 seats in BAMS (UG) course for the academic session 2017-18 under section 13A of the IMCC Act, 1970, subject to the condition that the college shall fulfill the laid down following requirements by 31<sup>st</sup> December, 2017 which will be verified for granting permission from the academic session 2018-19 onwards:

The fulfillment of the deficiencies pointed out in the Assessment Report of CCIM (if any) and the conditions given above may be made within the time period specified and compliance report should be submitted to the Ministry of AYUSH endorsing a copy to the CCIM also. The CCIM will verify that the conditions have been fulfilled by means of an inspection and submit a report in this matter to the Ministry of AYUSH for considering the permission matter from the academic session 2018-19.
